on your purchase of an eligible ENERGY STAR® qualified window unit air conditioner

This mail-in rebate is good for Austin Energy electric customers only and must be installed within the electric service area. To receive your rebate, please fill out this form completely and mail it to the address below with a copy of your dated sales receipt. Incomplete forms will disqualify or delay your rebate. All rebates must be submitted within 60 days of the purchase of your air conditioner.

ENERGY STAR® - Efficiency Requirements (for rebate):

To qualify for the \$50 incentive, the window unit air conditioner purchased must be ENERGY STAR® qualified and meet the minimum requirements listed below. You can visit www.energystar.gov to view a current listing of eligible window unit air conditioners.

SMALL UNITS UNDER 20,000 BTU'S 10.7 EER* or higher	LARGE UNITS 20,000 BTU'S or ABOVE 9.4 EER* or higher	*EER – window unit air conditioners are measured by Energy Efficiency Ratio. The higher the EER rating, the more efficient the window unit air conditioner.

Sizing of Air Conditioner.

Many people buy larger window unit air conditioners than they need, thinking that they will cool better, but an oversized unit has several disadvantages: oversized units are often more expensive initially and cost more to operate. In addition, oversized units can insufficiently dehumidify a room, leaving it uncomfortably damp.

Below is a chart for correct sizing based on the area to be cooled:
